#### Update on Late Dr John Fussey's fund.

The trustees of Chundikuli Trust Fund would also take this opportunity clarify the situation on of John Fussey Trust Fund,

#### **Background information**

#### 1. Dr Reginald John Roy Fussey's Will and the relationship with CTF

- o Dr Fussey passed away on 21st February 2017. In his will, he had bequeathed funds to G R Handy Memorial Trust.
- o In 2017, the executors of John Fussey's will expressed their intention to donate the fund to the G R Handy Memorial Trust Scholarship Fund, which was one of the SJC scholarship trust funds managed by CTF. This decision was made because the **Handy Memorial Trust** had become defunct. After conducting their research, the executors discovered the Dr. G R Handy **Memorial Scholarship**, which is managed by CTF, and chose to contribute the fund accordingly.

- The executor's lawyers wrote a letter addressing to then CTF President, Mr Tharma Chrishanthan on April 13, 2017, requesting clarification of CTF and connection between Handy Memorial Trust.
- CTF committee discussed and agreed to accept the donation.
- The first cheque of £70,000 was received on February 27th, 2018.
- The letter from the lawyers on behalf of the executor is very clear; there are no conditions attached to the donation.
- o A second cheque of £170,000 on October 19<sup>th</sup> 2018.
- o A third cheque of £19,503 was received on December 14, 2018.
- All the money were banked into CTF, no conditions were imposed on these gifts by the executors.
- Subsequent AGM minutes and CTF reports confirms the above.
- CTF's constitution states "The Trust is established for the advancement of education and the relief of poverty, suffering and distress amongst the students of Chundikuli Girl's College and St John's College and their families in Jaffna, Sri Lanka, in part by the provision of scholarships at the said colleges."

#### Formation of Eagle Care Trust in Sri Lanka

- From the total amount received, CTF sent £68,000 to SJC and £2,000 to CGC. Some money was also sent to SJC for medical project.
- CTF had requested SJC to use part of the funds to help a child with severe medical condition in Jaffna; the child sadly passed away
- The administration of SJC at that time and CMS Governing Body requested CTF not to send funds asking to conduct medical work.
- Until 2021, remainder of the John Fussey's funds were with CTF bank account in the UK.
- Eagle Care (guarantee) Trust Ltd incorporated on 13<sup>th</sup> Jan 2021 with the
  nature of the principal activities: "The objective for which the company is
  established are to advancement of education of the children at the school and
  higher education level in Sri Lanka by providing and assisting provision of
  facilities for their education".
- Rev. Jameson Gnanaponrajah (former principal of SJC), Mr Antonipillai (former vice principal of SJC), along with Mr Tharma Chrishanthan (the president of CTF) and other CTF trustees of that time - Mrs Nancy Gunaratnam and Dr Meera Gowripalan were appointed as directors of ECT and CTF trustee Mr Shailendra Sothinathan was appointed as a member of ECT.
- The remainder of the John Fussey fund was transferred from CTF account to Sri Lanka to be deposited into the ECT account.
- Agreement was that the fund was to be deposited on a fixed term deposit, interest to be used for the projects and **Eagle Care Trust shall remain**

under the care of CTF and that ECT shall produce audited accounts and forward to CTF.

#### 2. Complications and Proposals

- Until the formation of ECT, Dr G R Handy and Mr Fussey Memorial Trust Fund was with CTF and SJC.
- Funds were transferred to SriLanka ECT limited, deposited with NDB bank on 2-year and 3-year fixed deposits.
- Funds started maturing from April 2023.
- Presently, the current directors of ECT are not serving members of CTF or SJC.
- 31/3/2022 audited accounts of ECT was sent to CTF on request by the accountant.
- Since then, no annual reports of ECT has been sent to CTF.
- CTF trustees are not kept informed about the status of the funds or how they are spent.
- CSJPPA members also identified fiduciary duty to safeguard the assets and sked this to be done properly at the 2024 AGM.
- A proposal to put ECT into proper governance under CTF supervision, by appointing of current CTF trustees and the current principals of SJC and CGC has been in discussion.

#### 3. Efforts to Retrieve John Fussy Funds

- In 2024, CTF made numerous efforts to retrieve the John Fussey funds and bring them back under CTF control.
- At the 2024 AGM, the members unanimously agreed to take all necessary steps to resolve this matter once and for all.
- The proposal to return ECT under the control of CTF and the schools, was officially approved by both schools and governors.
- The proposal was that ECT directors shall be replaced by the current two principals of SJC and CGC along with 3 CTF trustees.
- Legal advice was obtained by CTF and letters were sent to Mr Tharma
   Chrishanthan through a solicitor to take the necessary action and replace the ECT directors.
- Lawyer's letter asserts the grounds in which CTF is requesting regularisation the ECT held CTF funds and the potential of further legal action.
- No court action has been started yet, either in the UK nor in Sri Lanka
- Letters were sent to current ECT directors to freeze the ECT funds and not to dissipate the assets until the matter is resolved amicably.
- Charity commission in UK was updated with the above processes.
- In the absence of cooperation from the ECT directors, negotiations were conducted through Mr. Benard Sinniah, Governor Mr. Sethukavalar, and the former SJC Principal, Rev. Gnanaponrajah. **Unfortunately, all three were**

unable to obtain any information regarding the funds or negotiations with Mr. Tharma Chrishanthan, who served as the Chairman of ECT and President of CTF when most of the money was transferred from the CTF account to ECT.

- CTF came to know by checking the company registers in Sri Lanka, that Mrs Nancy Gunaratnam and Dr Meera Gowripalan have resigned as ECT trustees, and two former archdeacons have replaced them.
- Later, through Mr Benard Sinnaiah and Gov. Mr Sethukavalar, CTF has been informed that Mr Tharma Chrishanthan has resigned as the director of ECT in 2024.
- But the replacement of the ECT directors with the two principals and 3 CTF trustees had not been put in place.
- o As per Governor Mr. Sethukavalar's advice, a letter was sent to the Bishop of the Church of Ceylon, asking him to intervene and resolve the matter without having to approach court proceedings.

#### 4. Proposed Actions

Further actions are being tabled and shall be followed through with a set period of time to achieve an amicable resolution to retrieve ECT Ltd's governance back into the status that is satisfactory to safeguard the charity's assets and ensure that the funds are appropriately allocated per the aims and objects of the charity

At the recent AGMs, senior members and trustees began questioning the ECT directors due to a lack of transparency surrounding ECT.

Current CTF trustees and the CSJPPA committee members urge the former ECT directors, members, CTF trustees and CSJPPA/CTF members to come forward and help resolve this matter.

We hope this newsletter provides clarity on the situation regarding the donation that CTF received from Late Dr John Fussey

The CSJPPA/CTF remains committed to transparency and working in the best interests of our Association, Charity and members. Your continued support and advice are invaluable as we work towards resolving these issues and ensuring the proper management of resources
